# Application & Membership Agreement

---

**Application for Membership Privileges.** The undersigned hereby makes application for a membership at Green Valley Country Club in the classification selected below by marking the appropriate box and agrees to pay the required Initiation Fee and applicable dues relative to the membership privileges desired.

Membership Directory. Contact information for club members will be included in the membership directory unless notified to be removed.

Membership application approval may be subject to a background and credit check.

**Payment of Initiation Fees.** With the submittal of this document, the undersigned has submitted an Initiation Fee payment for Membership as a Member of Green Valley Country Club.

**Payment of Membership Dues.** The undersigned agrees to pay the monthly dues in advance as shown on the monthly billing statement. The initial dues payment is required with the submittal of this document and payment of the applicable Initiation Fee payment.

Green Valley is a one year membership commitment. If the membership is terminated before the member's one year anniversary date of joining, the member is responsible for the balance of all dues payable upon the term of the one year membership. Members are not permitted to downgrade their membership classification prior to their one year anniversary date of joining.

Club Members who desire to resign their membership privileges must give the Club 90 days prior written notice of their intention to resign membership privileges. The resignation of membership privileges will become effective upon completion of the 90 day period with payment of the membership fee and all outstanding dues, fees and other charges in full to the Club. Dining minimum is applied during the 90 day period prior to resignation. Members who have resigned in good standing may be eligible to re-join the Club one year from their resignation date.

**Payment of Quarterly Dining Minimum.** The undersigned agrees to pay a quarterly dining minimum. A quarterly dining minimum will be charged each quarter to all Membership Classifications except NonResident Members. The quarterly dining minimum is an obligation to spend the required amount each quarter on dining purchases at the Club. If you do not meet the minimum in any given quarter, you are billed for the difference between your actual spending and your obligation. The obligation is per-quarter and not accrued on an annual basis. Applicable taxes and service charges do not apply towards the quarterly dining minimum.

**Receipt of Membership Plan and Rules and Regulations.** The undersigned has received, read and understands the Membership Plan and Rules and Regulations governing membership at Green Valley Country Club.

**Membership Privileges.** The undersigned understands that Members of the Club are allowed to use the Facilities provided at Green Valley Country Club in accordance with this Membership Plan. By obtaining a membership at Green Valley Country Club, Members obtain a non-exclusive revocable license to use the facilities in accordance with the classification of membership selected by the Member. Members do not obtain any equity or ownership interest in the Club or the Facilities provided at Green Valley Country Club, do not have and do not acquire any property rights or other interest in any property of the Club, do not have any rights to become involved in the management or operation of the Club or the Facilities provided at Green Valley Country Club and are not subject to any assessments for operating deficits incurred in the operation of the facilities provided at Green Valley Country Club or any assessments for capital improvements to the Club Facilities.

**Modification and Termination of the Membership Plan.** The undersigned understands that the Club reserves the right to reserve memberships for persons determined solely by the Club, to discontinue operation of any or all of the Club Facilities, to change the Club Facilities available for use by Club Members, to terminate this Membership Plan, to terminate all memberships at Green Valley Country Club with or without cause, to terminate any particular membership (selectively, if so desired by the Club) at Green Valley Country Club with or without cause, and to sell, lease or otherwise dispose of the Club Facilities, in whole or in part, to an equity Member-owned club or to any other third party. Any such recall and termination of a membership may be selective without regard to the date of the application or may be done on a last-in, first-out basis.

In addition, the Club further reserves the right to amend and modify this Plan for the Offering of Memberships in any manner it deems appropriate, in its sole discretion. All Club Members agree to be bound by any changes to this Membership Plan.

**Indemnification and Assumption of Risk.** By executing the Application for Membership Privileges and the Membership Agreement, Applicant hereby agrees to indemnify, defend and hold Green Valley Country Club (and their respective owners, directors, partners, officers, operators, employees, and other agents) harmless from and against any and all liabilities, costs (including reasonable attorney's fees), claims, demands or damages incident to or arising out of or relating to the acts or omissions of Applicant, their Family or guest(s), and their respective use or occupancy of the Facilities. In addition, by executing this Agreement, Applicant hereby voluntarily assumes all risks of accident or damage to Applicant's person or property, and the person or property of Applicant's Family and guests, arising out of or relating to the use or occupancy of the Facilities including but not limited to errant golf balls, operation of a golf cart, and adverse weather conditions including lightening.
